## VIDEO VISITATION RULES (OFF-SITE)

OFF-SITE SCHEDULE  
SUNDAY THROUGH SATURDAY  
9:00 AM – 9:00 PM

1. Off-Site or "home-based" video visits may be scheduled in advanced by the visitor through the Securus Video Visitation Website at [www.securustech.net/videovisitation](http://www.securustech.net/videovisitation).
2. Visits are scheduled at the top/bottom of the hour only (ie 9:00am, 9:30am).
3. The registering visitor must be at least 18 years of age and present a valid, government issued photo identification through the registration process. Approvals are generally made within 24 hours, excluding holiday and weekends.
4. The duration of each visit is 30 minutes. Inmates are not restricted as to the number of off-site video visits they may receive in a week. On-site visits are restricted to 1 visit per week.
5. All video visitations, except professional, are recorded and subject to electronic monitoring by the Barron County Jail.
6. The visitor and inmate are responsible for being present at the start of the scheduled visit. Visitors signing in late will only receive the balance of the remaining time for the scheduled visit.
7. No NUDITY, provocative clothing, or tight fitting clothing will be allowed during the visit. Violators will be barred from both on-site and off-site visitation for a period of time determined by the Jail.
8. Visitors appearing to be under the influence of alcohol or drugs, displaying items that may be considered contraband such as drugs, drug paraphernalia, weapons, or displaying gang signs, symbols, colors, ect. are subject to having the visit cancelled and are barred from future visits.
9. Visitors 17 years of age and under must have a parent or guardian present during the off-site visit.
10. Any type of provocative or disruptive behavior will not be permitted.
11. If you are experiencing a problem with the audio or video reception during the visit, please refer to the Securus Video Visitation website for assistance. Any refunds or questions concerning the operation of the video visitation system should be addressed by contacting Securus Technologies, Inc., at Securus Video Visitation Support: 1-877-578-3658.
12. Inmate Workers will not be able to leave their assigned work areas. It will be the responsibility of the inmate worker to know his/her schedule and report that to visitors.
13. Inmates participating in jail programming such as church service or meeting with their attorney and other professional practitioners will not be allowed to leave their assigned area. Inmates should let visitors know the programming schedule to avoid conflicts.
14. Videotaping of any visitation is prohibited.

The Barron County Jail reserves the right to deny, cancel or terminate a video visit prior to or during a video session based upon visitor or resident inmate misconduct. The Barron County Jail also reserves the right to restrict a visitor from participating in all future use of the system.
